Section 4. First-aid measures

Inhalation IF INHALED: Remove person to fresh air and keep comfortable for breathing. Get medical attention if you feel unwell. IF

Section 5. Fire-fighting measures

In case of fire: Use carbon dioxide, chemical powder agent and appropriate foam to extinguish.

Special protective equipment and precautions for fire-fighters

During a fire, irritating/toxic smoke and fumes may be generated. Do not enter fire area without proper protection. Methods and materials for containment and cleaning up

Ventilate area of release. Stop the leak if it can be done safely. Contain and absorb any spilled liquid concentrate with inert absorbent material, then place material into a container for later disposal (see Section 13). Section 7. Handling and storage

Precautions for safe handling

Wear gloves/protective clothing/eye protection/face protection.

Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Inspect periodically for damage or leaks.
