Section 4. First-aid measures

Section 5. Fire-fighting measures

In case of fire: Use carbon dioxide, chemical powder agent and appropriate foam to extinguish.

Special protective equipment and precautions for fire-fighters

During a fire, irritating/toxic smoke and fumes may be generated. Do not enter fire area without proper protection. Ventilate area of release. Stop the leak if it can be done safely. Section 7. Handling and storage

Precautions for safe handling

Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Inspect periodically for damage or leaks.
