Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Restrict access to area until completion of clean-up. Ensure clean-up is conducted by trained personnel only. All persons dealing with clean-up should wear the appropriate protective equipment (See Section 8).

Methods and materials for containment and cleaning up

Ventilate area of release. Stop the leak if it can be done safely. Precautions for safe handling

Inspect periodically for damage or leaks.
